## SKOOLFONDS 2021

Die jaarlikse skoolgeld vir 2021, soos aanbeveel deur die Beheerliggaam en goedgekeur op die Algemene Jaarvergadering van 11 November 2020, is soos volg:

- Eerste twee leerders R25 950.00 elk waarvan R1 750 per leerder reeds betaal is in Desember 2020 en die verskil teen R2 200 per maand is betaalbaar oor 11 maande vanaf 1 Januarie tot 1 November 2021.
- Indien skoolgeld ten volle betaal is teen 28 Februarie 2021, sal een maand se afslag (R2 200) per leerder toegestaan word.

Skoolgeld word gehef vir 11 maande vanaf Januarie tot November en is maandeliks betaalbaar voor of op die 7de van elke maand. 'n Gedeelte van die skoolgeldpaaient per leerling vir die daaropvolgende jaar, is in Desember van elke jaar betaalbaar.

### AGTERSTALLIGE SKOOLGELD

Die betaling van skoolgeld is kragtens die Skolewet, 1996 (No 84 van 1996) verpligtend. Tensy u volgens Artikel 39 van die Skolewet kwalifiseer vir vrystelling van skoolgeld, sal u aanspreeklik gehou word vir die invordering van skoolgeld. Ouers wat finansiële probleme het met skoolgeld betaling, kan 'n kwytsekdingsvorm by die kantoor aanvra en 'n afspraak met Mnr. A Heydenrych reël.

### BETAAL METODES

#### • Elektronies

Stuur asb. duidelike bewyse van die betaling met die leerling se rekeningnommer en leerder se van om verwarring op die bankstaat te vermy. Die bankbesonderhede is soos volg: ABSA BANK, TAKKODE: 632005, TJEKREKENING: 260390449. Enige navrae by die bank om die identiteit van 'n betaling op te spoor, is vir die koste van die betaler.

#### • Debiet of Krediet kaart

Die skool beskik oor 'n debiet/Kredietkaart fasiliteit.

#### • Debiet order

Om die risiko van kontant se hantering uit te skakel, doen ons 'n beroep op u om u skoolgeld betalings per debietorder te doen. Die voordeel van 'n debiet order is onder meer dat U nie kontant saam met U hoef te dra nie.

## SCHOOL FEES 2021

The annual school fees for 2021, as recommended by the Governing Body and approved at the Annual General Meeting of 11 November 2020, are as follows:

- First two learners R25 950.00, each of which R1 750 per learner has already been paid in December 2020 and the difference of R2 200.00 per month is payable over 11 months from 1 January to 1 November 2021.
- If school fees have been paid in full by 28 February 2020, one month's discount (R2 100.00) per learner will be granted.

School fees are charged for 11 months from January to November and are payable monthly before or on the 7th of each month. A portion of the school fee instalment per pupil for the following year is payable in December of each year.

### ARREARS OF SCHOOL FEES

The payment of school fees is compulsory under the Schools Act, 1996 (No 84 of 1996). Unless you qualify for exemption from school fees under Section 39 of the Schools Act. Parents who have financial problems with school fees payment can request a waiver form at the office and make an appointment with Mr. A Heydenrych.

### PAYMENT METHODS

#### • Electronic

Please send clear proof of payment with the learner's account number and learner's surname to avoid confusion on the bank statement. The bank details are as follows: ABSA BANK, BRANCH CODE: 632005, CHECK ACCOUNT: 260390449. Any inquiries at the bank to find out the identity of a payment are at the cost of the payer.

#### • Debit or Credit card

The school has a debit / credit card facility.

#### • Debit order

To eliminate the risk of cash handling, we urge you to make your school fees payments by debit order. The advantage of a debit order is, among other things, that you do not have to carry cash with you.
